

ORDINANCE NUMBER 97-011

AN ORDINANCE ESTABLISHING THE POSITION OF PLANNING AND ZONING REPRESENTATIVE FOR THE CITY OF PIONEER VILLAGE, BULLITT COUNTY KENTUCKY, FIXING THEIR QUALIFICATIONS AND COMPENSATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY, AS FOLLOWS:

SECTION ONE: APPOINTMENT

THE PLANNING AND ZONING REPRESENTATIVE:

1. Shall be appointed by the Mayor of the City with the approval of the City Council.
2. May not be related to the Mayor, any council member, or any City employee.

SECTION TWO: DUTIES AND OBLIGATIONS

THE PLANNING AND ZONING REPRESENTATIVE:

1. Must attend ALL Bullitt County Planning and Zoning meetings, regular and called.
2. Must attend All City of Pioneer Village REGULAR MEETINGS and ALL SPECIAL MEETINGS PERTAINING TO PLANNING AND ZONING.
3. Must present a copy of all Bullitt County Planning and Zoning meeting minutes to the Mayor and all City Council members

SECTION THREE: TERM OF OFFICE

The term of office shall be four (4) years, commencing on July 1, 1998.

SECTION FOUR: DISCIPLINARY ACTION

Failure to attend more than two (2) meeting of the Bullitt County Planning and Zoning Commission or of the City of Pioneer Village, in one calendar year, is grounds for immediate removal from office.

The mayor of the City of Pioneer Village, Bullitt County, Kentucky may vacate this office if any of the requirements set forth are not followed, as well as the statutory grounds, set forth in chapter 100 KRS.

SECTION FIVE: COMPENSATION

Compensation will be that which is set by the Bullitt Fiscal Court or Bullitt County Planning and Zoning Commission.

SECTION SIX: EFFECTIVE DATE

This ordinance shall take effect immediately upon publication

SECTION SEVEN:

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
