

ORDINANCE NO 99- 004

AN ORDINANCE ESTABLISHING A GENERAL BUDGET FOR THE 1999 FISCAL YEAR IN THE CITY OF PIONEER VILLAGE.

WHEREAS, the City of Pioneer Village, Bullitt County, Kentucky, has established the City of Pioneer Village 199 fiscal year budget and which sets forth anticipated revenue, by source and anticipated expenditures by general types, classification, and supplier.

The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does ordain as follows:

SECTION ONE: The full and complete line item revenues and expenditures are set forth in Exhibit A.

SECTION TWO: This Ordinance shall take effect upon publication.

SECTION THREE: This Ordinance shall be published according to law.

SECTION FOUR: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

SECTION FIVE: Any Ordinance or part of Ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

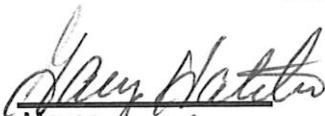
