

WHEREAS, the General Assembly of the Commonwealth of Kentucky has established the County Employees Retirement System, and

WHEREAS, the governing body of the City of Pioneer Village is of the opinion that participation in this Retirement System is in the best interest of the general welfare of the City of Pioneer Village and the employees and officers thereof, and

WHEREAS, the governing body of the City of Pioneer Village is cognizant of the requirements and benefits of the County Employees Retirement System as provided for in KRS 78.510 to 78.990.

WHEREAS, the governing body of the City is aware of the provisions under KRS 78.530-2, once a city participates it shall thereafter continue to participate except as provided in KRS 78.535, and

WHEREAS, the governing body is aware of the continuing liability if the agency should be terminated under the provisions of KRS 78.535,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PIONEER VILLAGE, KENTUCKY:

That this city be and is hereby authorized to participate in the County Employees Retirement System effective July 1, 2004, and that all eligible regular full-time officers and employees of this city are hereby authorized and directed to comply with the statutory requirements of this Retirement System.

FURTHER BE IT RESOLVED, that all the employees of this city whose duties require an average of 100 hours, "of actual work," during each working month be considered as "regular full-time" employees for County Retirement System purposes except those employees of agencies excluded as shown below which may participate in the system as a separate agency and those other persons of the County Employees Retirement Laws. FURTHER BE IT RESOLVED, the Mayor and the City Council are considered (full-time)/ (part-time) employees for County Employees Retirement System purposes.

The above Ordinance was adopted on roll call, the voting resulting as follows:
