ORDINANCE NO. 2005-04

AN ORDINANCE LEVYING PERSONAL PROPERTY AD VALOREM TAXES AND PROVIDING ASSESSMENT, EQUALIZATION AND COLLECTION IN ACCORDANCE WITH KRS 92.280, ET.SEQ.

BE IT ORDAINED, by the City Council of the City of Pioneer Village, Bullitt County, Kentucky, as follows:

SECTION ONE: A personal property ad valorem tax of 13.3 cents on each \$100.00 of all personal property taxable for municipal purposes, except property assessed by the State in said City, is hereby levied for the year 2005 as of January 1, 2005.

SECTION TWO: Said levy is made for the purpose of raising revenue to pay salaries of officers and employees; for the repair and maintenance of street, public ways, and public buildings in said city; to pay for lighting city streets; and to pay all proper charges and legal demands against the City.

SECTION THREE: The assessment made by the Bullitt County Property Valuation Administrator for State and County purposes for 2005 shall be and is hereby adopted as the assessment for City purposes. These taxes as they relate to motor vehicles and boats shall be collected by the Bullitt County Clerk as provided by KRS 132.487 et.seq.

SECTION FOUR: The City Clerk be and she is hereby directed to forward to the Department of Property Valuation, 200 Fair Oaks Lane, Frankfort, Kentucky 40620, a 2005 Motor Vehicle Tax Rate Certification for the year 2005.

SECTION FIVE: The Clerk is directed to advertise this Ordinance as provided by law.

SECTION SIX: All payments of taxes provided for herein shall be received by the City Clerk/Treasurer at the business office of City of Pioneer Village, 4700 Summitt Drive, Louisville, Kentucky 40229.

SECTION SEVEN: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.


SECTION EIGHT: Any ordinance or parts of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

Given second reading, voted upon, and passed at a regular meeting of the City Council of the City of Pioneer Village, Bullitt County, Kentucky, on the 27th day of August, 2005.


