

ORDINANCE NO. 2008-07

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Pioneer Village, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

BEGINNING at a point in Southeast corner of Lot 49, Pope Subdivision, Plat recorded in Deed Book 85, Page 29, in west line of Wendy Hill Drive; thence S 10° E 120 to an old pipe; thence S 83° 15' W 303.2 feet (for S 85° W 306 feet) to an old pipe; thence N 0° 30' E 116.4 feet (for N 1° E 120 feet); thence N 82° 30' E (for No 85° E) 280 feet to a point of beginning and being Lots 50 and 51 of Pope Subdivision plat of which is recorded in Deed Book 85, Page 29, in the office of the Clerk of Bullitt County Court.

There is also included right to use of road from above property to Kentucky State Highway No. 61.

Lot Number Forty-Nine (49) as shown on plat of Pope Subdivision recorded in Deed Book 85 Page 29 in the office of the Clerk of Bullitt County, Kentucky.

There is also included right to use of road from above property to Kentucky State Highway Number 61.

SECTION II: The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Pioneer Village.

SECTION III: The Mayor of the City of Pioneer Village, Bullitt County, Kentucky, having received prior written consent of each owner of record of the land herein before described requesting annexation into the City of Pioneer Village, and no resident voters who oppose annexation existing in this area, and all provisions of KRS 81A.412 having been complied with, the herein before described property is annexed into the City of Pioneer Village, Bullitt County, Kentucky.

SECTION IV: This Ordinance shall be published according to law.


SECTION V: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION VI: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION VII: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of the Ordinance.

Given first reading at a regular meeting of the City Council of the City of Pioneer Village, Bullitt County, Kentucky on the 23rd day of December, 2008. Given second reading, voted upon and passed at a special meeting of the City Council of the City of Pioneer Village, Bullitt County, Kentucky, on the 29th day of January, 2009.
