

ORDINANCE NO. 2010-02

AN ORDINANCE ADOPTING THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2010, THROUGH JUNE 30, 2011, BY ESTIMATING REVENUES AND EXPENDITURES FOR THE OPERATION OF CITY GOVERNMENT.

WHEREAS, an annual budget proposal and message has been prepared by the Mayor and delivered to the City Council; and

WHEREAS, the City Council has reviewed such budget proposal and made modifications as required;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PIONEER VILLAGE, AS FOLLOWS:

SECTION I: The annual budget for the fiscal year beginning July 1, 2010, and ending June 30, 2011, is hereby adopted as follows:

SECTION II: This Ordinance shall take effect on July 1, 2010.


SECTION III: This Ordinance shall be published according to law.
