

## ORDINANCE NO. 2015-04

AN ORDINANCE PROPOSING THE ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does hereby ordain that it proposes to annex certain unincorporated territory to the City of Pioneer Village, Bullitt County, Kentucky, and that such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory proposed to be annexed is described as follows:

BEGINNING at a pipe in the South line of a 30 foot Street; thence North 53 East 77 feet to corner with Lot No. 2; thence South 42-1/2 East 200 feet to a stake in North line of State Highway No. 61; thence South 59 West 63 feet with line of said Highway to a pipe; thence North 45-1/2 West 200 feet to the beginning; being Lot No. 1, as shown on plat of POPE SUBDIVISION, recorded in Deed Book 85, Page 29, in the office of the Clerk of the Bullitt County Court.

SECTION II: The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Pioneer Village.

SECTION III: This Ordinance shall be published pursuant to the provisions of KRS Chapter 424 and if within sixty (60) days of the publication, fifty percent (50%) of the resident voters and/or owners of real property within the limits of the territory proposed to be annexed wish to oppose said annexation, they shall petition the Mayor expressing their opposition to this annexation and request that this issue be placed on the next regular election ballot.

SECTION IV: Resident voters and/or owners of real property within the limits of the territory proposed to be annexed who wish to oppose said annexation shall deliver their petition to the Mayor at 4700 Summitt Drive, Louisville, Bullitt County, Kentucky 40229, prior to the expiration of sixty (60) days from the publication date, being no later than the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_. Based on the records maintained by the Bullitt County Property Valuation Administrator the property owners are Frieda Joyce Stone and Stephen Stone.

SECTION V: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION VI: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of the Ordinance.
