

ORDINANCE NO. 2018-03**AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY.**

The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does hereby ordain that it proposes to annex certain unincorporated territory to the City of Pioneer Village, Bullitt County, Kentucky, and that such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory proposed to be annexed is described as follows:

Beginning at an iron pin (PLS #3226) having Kentucky North (1601) State Plane Coordinates of N 205494.41, East 1230115.99 (NAD83). Said Pin being the southwest corner of Carolyn Keller and Ron Meadors, her husband, Deed Book 941 Page 286 in the east boundary of the City of Pioneer Village as established in Annexation Ordinance #82-3 (pre KRS 81A.470).

In the East right of way of Old Preston Highway, thence with the East right-of-way of Old Preston Highway N 23° 08' 17" E, 137.36' to an iron pin set (B. L. Lambert, PLS 3226), thence leaving the right-of-way S 83° 29' 45" E, 370.70' to an iron pipe in the West right-of-way of Faro Circle, thence with the West right-of-way of Faro Circle S 23° 27' 24" W, 137.25' to an iron pipe, thence leaving the right-of-way N 83° 32' 45" W to the point of beginning containing 1.118 acres per survey by Bobby L. Lambert, PLS 3226 on July 5, 2018.

SECTION II: The City Council of the City of Pioneer Village, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Pioneer Village.

SECTION III: The Mayor of the City of Pioneer Village, Bullitt County, Kentucky, having received prior written consent of each owner of record of the land herein before described requesting annexation into the City of Pioneer Village, and no resident voters who oppose annexation existing in this area, and all provisions of KRS 81A.412 having been complied with, the herein before described property is annexed into the City of Pioneer Village, Bullitt County, Kentucky.

SECTION IV: This Ordinance shall be published according to law.

SECTION V: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION VI: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION VII: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of the Ordinance.

Given first reading at a regular meeting of the City Council of the City of Pioneer Village, Bullitt County, Kentucky on the 26th day of June, 2018. Given second reading, voted upon and passed at a regular meeting of the City Council of the City of Pioneer Village, Bullitt County, Kentucky, on the 24th day of July, 2018.
