

AN ORDINANCE AMENDING THE BUDGET ORDINANCE FOR THE CITY OF PIONEER VILLAGE, KENTUCKY, FOR THE FISCAL YEAR JULY 1, 1984 TO JUNE 30, 1985

ORDINANCE NO. 86- 1

Be it ordained by the City Council of the City of Pioneer Village, Kentucky, that the budget ordinance for the fiscal year July 1, 1984 to June 30, 1985, is amended as follows:

SECTION I. The general fund accounts are amended as follows:

- A. Property tax revenues are amended from \$36,000.00 to \$12,705.00.
- B. Intergovernmental revenues are amended from \$11,685.00 to \$7,049.00.
- C. Interest revenues are amended from \$0.00 to \$108.00.
- D. Other revenues are amended from \$0.00 to \$1,421.00.
- E. Total revenues are amended from \$47,685.00 to \$21,283.00.
- F. General government expenditures are amended from \$21,950.00 to \$18,255.00.
- G. Police expenditures are amended from \$12,400.00 to \$11,322.00.
- H. Streets expenditures are amended from \$0.00 to \$869.00.
- I. Debt service expenditures are amended from \$8,000.00 to \$1,451.00.
- J. Total expenditures are amended from \$42,350.00 to \$31,897.00.

SECTION II. The special revenue accounts are amended as follows:

- A. Intergovernmental revenues are amended from \$22,000.00 to \$2,436.00.
- B. Interest revenues are amended from \$0.00 to \$161.00.
- C. Total revenues are amended from \$22,000.00 to \$2,597.00.
- D. Police expenditures are amended from \$7,500.00 to \$0.00.
- E. Streets expenditures are amended from \$10,500.00 to \$0.00.
- F. Debt service expenditures are amended from \$2,000.00 to \$0.00.
- G. Total expenditures are amended from \$20,000.00 to \$0.00.

SECTION III. This ordinance shall be published according to law and shall become effective upon publication.

SECTION IV. Should any section, clause, line, paragraph, or part of this ordinance be held unconstitutional or invalid for any reason, same shall not affect the remainder of this ordinance.


*SECTION IV. An emergency is declared in order to comply with state reporting requirements and the second reading is waived.*

By the required two-thirds vote.


