

AN ORDINANCE PROPOSING TO ANNEX CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF PIONEER VILLAGE, PURSUANT TO PROVISIONS OF KENTUCKY REVISED STATUTES 81A.400, et seq.

ORDINANCE NO. 91-02

THE CITY COUNCIL OF THE CITY OF PIONEER VILLAGE DOES ORDAIN AS FOLLOWS:

SECTION I. It appearing that the prosperity of the City and of the territory herein described will be materially retarded and the safety of the inhabitants and property thereof endangered if such territory is not annexed.

SECTION II. The annexation of such territory is deemed necessary for the welfare of the residents and property owners thereof and of the City as a whole.

SECTION III. There is hereby proposed to be annexed to the City of Pioneer Village, County of Bullitt, State of Kentucky, and incorporated with the corporate boundaries thereof, the following territory adjoining the present corporate boundaries of the City of Pioneer Village, and being more particularly described as follows:

BEGINNING at the intersection of the south line of Hebron Lane and the west line of Kentucky Highway 61 (Preston Highway), Thence south with the west line of Ky. 61 to a point where the south line of Hebron Estates intersects the west line of Kentucky 61. Thence in an easterly direction across Ky. 61 to the east line of Ky. 61. Thence in a southerly direction along the east line of Ky. 61 to a point 280 ft. south of the centerline of Joy Lane. Thence in a northerly direction across Ky. 61 400 ft. to a point. Thence parallel with Ky. 61 at 340 ft. from the west line in a northerly direction to a point in the south line of Hebron lane. Thence in an easterly direction 340 ft. to the point of beginning.

SECTION IV. The corporate limits of the City of Pioneer Village are hereby extended and increased so as to include and to embrace within the corporate limits of the City of Pioneer Village, the territory described in Section III hereof, and such territory is hereby declared to be a part of the city of Pioneer Village.

SECTION V. The map attached to this Ordinance is a accurate map of the territory annexed and such map is hereby adopted as the official map of the territory annexed, and the Mayor of the City of Pioneer Village is hereby authorized to direct and certify that the map is an accurate map of the territory annexed under the provisions of this Ordinance, and to record in the Office of the County Clerk of Bullitt County, Kentucky this Ordinance together with a certified copy of the official map attached.
