

AN ORDINANCE AMENDING THE BUDGET ORDINANCE FOR THE CITY OF PIONEER VILLAGE, KENKUCKY., FOR THE FISCAL YEAR JULY 1, 1990 TO JUNE 30, 1991.

ORDINANCE 92-03

Be it ordained by the city Council of the City of Pioneer Village, Kentucky, that the budget ordinance for the fiscal year July 1, 1990 to June 30, 1991 is amended as follows:

SECTION 1. The general fund accounts are amended as follows:

- A. General property tax revenues are amended from \$35000. to \$31768.
- B. Licenses are amended from \$15000. to \$12644.
- C. Intergovernmental revenues are amended from \$11910. to \$12355.
- D. Other revenues are amended from \$2000 to \$4585.
- E. General government expenditures are amended from \$13810. to \$16285.
- F. Police expenditures are amended from \$1700. to \$29136.
- G. Streets and right ways expenditures are amended from \$7200. to \$746.
- H. Public Safety expenditures are amended from \$9000. to \$10668.
- I. Debt service expenditures are amended from \$7500. to \$5760.
- J. Emergency and discretionary expenditures are amended from \$5900. to \$0.00

SECTION II. This ordinance shall be published according to law and shall become effective upon publications.

SECTION III. Should any section, clause, line paragraph, or part of this ordinance be held unconstitutional or invalid for any reason, same shall not affect the remainder of the ordinance.
