October 6, 2009
7:00 p.m.

Present: Mayor Clark, Commissioners Forshee, Allen, Duddy, Tucker, Clerk Picheo, Officer Cook, Officer Larding, Magistrate Joe Laswell and 15 guests.

Minutes: Motion to approve the September 1, 2009 minutes was made by Comm. Tucker and was seconded by Comm. Duddy; Passed 4/0.

Budget: A copy of the monthly budget statement was handed out and reviewed. Motion to pay monthly bills was made by Comm. Tucker and seconded by Comm. Forshee; Motion Passed 4/0.

Guest Speaker: Mr. Davis led a discussion on his drive to collect books for rural areas of Kentucky. He explained that he has been diagnosis with terminal cancer (with a life expectancy of 6 months) and explained that he feels that why try not try and improve the future generation. Officer's Report: Officer Cook reported a total of 11 tours for September with 20 hours worked. Officer Cook reported on some concerns that were raised from a resident regarding drug activity. Officer Cook reported that the Drug Task force did investigate however, did not find anything. The officer also reported on a call from dispatch regarding a possible drug sell however, after the investigation and search no drugs were found in the suspect's car. The suspect did approach Officer Cook at a football game the following weekend and explained that he understand the consequences and that he would not be in trouble again. Officer Cook also reported on a burglary on Scenic Trail. The officer did report that the only thing missing was a set of keys.

Officer Larding reported 20 hours worked with 16 visits and 10 traffic stops, with 6 citations (4 for speeding, and 2 for Stop sign violations). The officer reported on a wandering individual who was knocking on doors. The individual did say that he had been to a party the night before and did not know where he was. The individual did get a ride home. Officer Larding led a discussion on an effective way to reduce speed with the majority of school traffic. He explained that he tries to get in the middle of the traffic pattern to reduce speed from behind him while radaring in front of him. The officer also explained that North Bullitt does have an enforcement officer now and has been working to control the speeders. Officer Larding reported on a scam that a resident had filed a complaint on. The resident stated that an individual came to her door trying to sell her a home security system from APX. After the resident refuse to allow the person into her home he left and she then found out on the internet that he was part of a scam to rob people. The Officer asked that if anyone sees any suspicious activity to please call dispatch.

Business: Comm. Duddy led a discussion on the lot on Willow Way. The commissioner explained that he had received complaint regarding trash and not being mowed. Mayor Clark read a letter that was sent to the owners notifying them of the problems. Mayor Clark stated that the lot was mowed.

New Business: Mayor Clark led a discussion on the 7 delinquent residents that had not paid their garbage bills. Comm. Forshee asked if a letter had been sent. Mayor Clark said, "yes". A motion was made by Comm. Tucker to file suit for the delinquent garbage accounts, motion was seconded by Comm. Duddy; Passed 4/0.

Mayor Clark reminded everyone that the stream walk will be on Oct 17th at the old Winn Dixie parking lot with a start time of 8:00 am. The rain date will be Oct 24th.

A guest spoke up and raised a concern with the city regarding passing a no solicitation policy except for non-profit organizations (such as schools). Mayor Clark stated that he would ask Atty. Edison to draft an ordinance for discussion.

Mayor Clark led a discussion on moving the annual yard sale date from the first Saturday in October to the weekend after Labor Day. Everyone was in agreement to move the date.

Mayor Clark read a notice from Little Flock inviting the community to attend a Wellness Fair.

Motion to adjourn the meeting at 8:15 pm was made by Comm. Tucker and seconded by Comm. Forshee Passed 4/0.
