

**ORDINANCE NO. 2021-06**

AN ORDINANCE AMENDING THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2020, THROUGH JUNE 30, 2021.

WHEREAS, on the 26th day of May, 2020, the City Council of the City of Pioneer Village did adopt Ordinance No. 2020-01 AN ORDINANCE ADOPTING CITY OF PIONEER VILLAGE, KENTUCKY, ANNUAL BUDGET FOR FISCAL YEAR JULY 1, 2020, THROUGH JUNE 30, 2021, and
